


I. Project Duration

360 days from the commencement date (Including public holidays, excluding approval periods)

J. Additional Information:

- 1. Any additional documents or information provided during the competition period will be posted on the competition website (designarchi.kr). Participants are responsible for checking updates, and any consequences resulting from failure to do so shall be borne solely by the participant.
- 2. This project requires liability insurance (or equivalent guarantee). The selected contractor must submit a liability insurance certificate or guarantee certificate to the client, in accordance with Article 21, Paragraph 2 of the Enforcement Decree of the Architects Act.
- 3. The design service fee includes all costs related to concept, schematic, and detailed design, surveying, geothermal drilling, green building & zero-energy certification, preliminary BF (Barrier-Free) certification, approval processes, and other necessary expenses.

2. Contract Method

The selected winner will enter into a negotiated contract based on the aforementioned **design fee**.

3. Design Competition Method

This design competition will be conducted as an **open competition** (joint participation allowed).

4. Eligibility Requirements

- A. Qualification Criteria (Must meet at least one of the following conditions):
 - A licensed architect under Article 7 of the Architects
 Actwho has registered an architectural firm in accordance with Article 23 of the same Act, with no legal disqualifications.
 - 2. A foreign architect who has obtained a qualification under **Article 21-2 of the Enforcement Decree of the Architects Act**and has formed a joint work agreement with a domestic architectural firm (in this case, the domestic firm must be the primary representative).

B. Disqualification Conditions

- 1. As of the application registration date, any individual or firm whose registration has been canceled, is suspended or closed, or is under any administrative restriction such as a business suspension, shall be ineligible to participate.
 - X Participants, including joint applicants, must submit proof from an accredited institution confirming that they are not under a business suspension.
- 2. Each participant may submit only **one design proposal**. If multiple submissions from the same participant are discovered, their eligibility will be revoked.
- 3. Individuals who do **not meet the qualification criteria**or have **not registered a representative**for participation will be **disqualified from submission**, and submitted proposals **cannot be revised or supplemented**.



5. Joint Participation

A. Requirements for Joint Participation

- All joint participants must meet the qualification criteria specified in **4.A.1**) or **4.A.2**), and a **single representative**must be designated.
- The designated representative will hold all legal rights and responsibilities for the project.
 - **X** Required submissions: **Joint Participation Agreement (Form 7) and Representative Appointment Form (Form 8).**

B. Joint Contracting for Specific Design Areas

- If the winning participant lacks the necessary qualifications for **telecommunication or fire protection design**, they must enter into a **joint contract (partial execution method)**with a qualified firm in the respective field.
- In such cases, the competition winner will act as the representative in the contract.
 - 1. **Telecommunication Design**must be carried out by a licensed entity under the Telecommunications Business Act.
 - 2. Fire Protection Designmust be carried out by a licensed entity under the Fire Services Act.



- 1. Submit the application form and required documents via the competition website.
- 2. The application must be submitted by the representative or an authorized proxy (limited to employees of the representative's firm).

- 3. All original documents(except for copies) must be issued between the announcement date and the application deadline.


